

## ORDER

Having heard the legal representative for the Applicant and having read the documents filed of record,

## IT IS ORDERED THAT:

- The Respondent's business rescue proceedings are discontinued in terms of Section 141 (2) (a) (ii) of the Companies Act 71 of 2008 ("the Companies Act").
- 2. The Respondent is hereby placed under Provisional Liquidation.
- 3. A rule *nisi* be issued calling upon all persons interested to appear and show cause, if any, to the above Honourable Court on **27 May 2015** why:
  - 3.1 the Respondent should not be placed under Final Liquidation; and
  - 3.2 the costs of this application should not be costs in the liquidation.
- 4. Service of this order be effected by:
  - 4.1 The Sheriff of the High court at:
    - 4.1.1 The registered address of Respondent; and
    - 4.1.2 The South African Revenue Services; and

By one publication in the following newspapers:

- 4.2.1 The Cape Times, and
- 4.2.2 Die Burger;
- 4.3 On the employees of Respondent by affixing a copy thereof to a notice board on Respondent's premises, alternatively by affixing a copy thereof at the entrance of the premises, if applicable.
- 4.4 by prepaid registered post on all known trade unions and/or bargaining councils of the employees, if applicable;
- 4.5 by electronic mail on all known potential affected persons set out in Annexure "A" hereto;
- 4.6 by prepaid registered post on the members of the Respondent.
- 5. In terms of Section 357 (a) of the Companies Act 61 of 1973 read with Section 19 of the Insolvency Act 1936,
  - 5.1 the Registrar shall transmit a copy of both the provisional and final orders to the Sheriff of the province in which the registered office of the Company is situated and to the Sheriff of every province in which it appears that the Company owns property;
  - 5.2 the Sheriff shall attach or property which appears to belong to the Company and transmit to the Master and inventory of all property attached by him or her in terms of Section 19 of the Insolvency Act of 1936.
