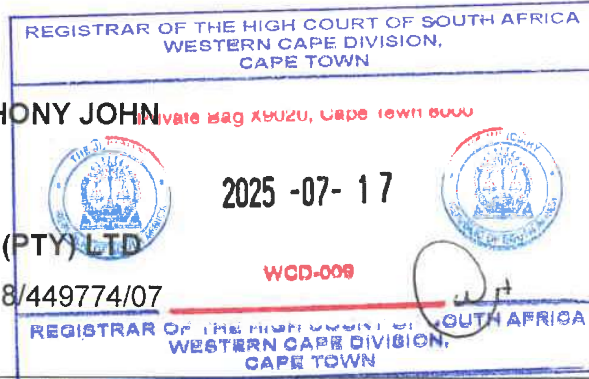

**DRAFT ORDER**

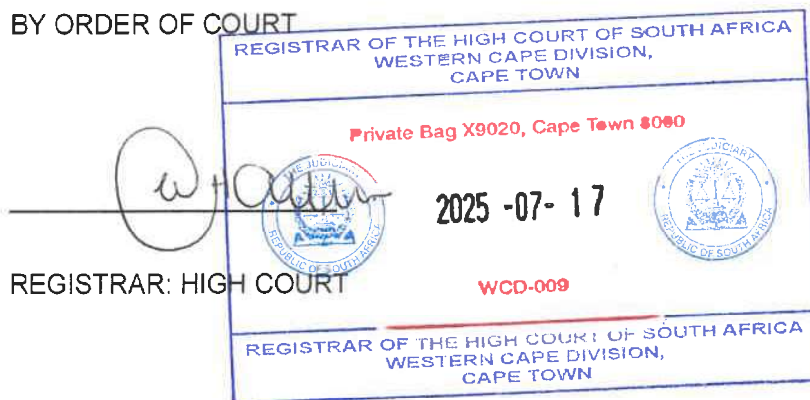
Having heard counsel for the Applicant and read the papers filed as of record, it
