- I am a South African and the appointed director of ROBERT STAMPORD VINEYARDS (Ptv). Ltd ("the Company") with registration number 2003/017336/07 and business address at 1166 Courtyard, Gents Cookre, Strand, 7140.
- The contents of this swom statement are true and correct and, unless stated otherwise. the facts contained herein fall within my own personal knowledge and belief.
- 3 I was duly appointed as director of the Company on 8 July 2004.
- I make this sworn statement in support of the Company's notice to commence business rescue proceedings as contemplated in terms of Section 129 of the Companies Act, 71 of 2008 ("the Act").
- On 24 August 2018, the board of directors of the Company unanimously resolved that the Company voluntarily commence business rescue proceedings as envisaged in terms of the Act. The resolution will be filed together with this swom statement.
- The relevant facts upon which the resolution were founded include:
- The Company's main business is that of wine farming. 5.1
- 5.2 The Company is indebted to its creditors in an amount of approximately \$12.1m and presently unable to pay these debts some of which became due and payable.
- 6.3 The Company requires time in order to restructure its affairs, debt and equity so that the creditors of the Company are afforded maximum benefit.
- As mentioned in 7 below the Company is financially distressed as envisaged in terms of 6.4 the Act.
- Funding from sources such as shareholder loans and loans the company's financiers has 6.5 caused or is about to cease.

The Company is faced with the situation where it needs to realise its assets or to 1.6 procure further funding to best effect and to negotiate with its creditors which process will be best achieved under business rescue proce dings as a processing with the KOMMESS VITMAATSKAPPTE NTS LEKTUELD EIEHOOM OUR BREMINGSREADING Act.

- 7 As director I investigated the Company's affairs and concluded that the Company is "financially distressed" as defined in section 128 of the Act as it is reasonably unificely to be able to pay all its debts as they become due and payable within the immediately ensuing six months and/or the Company is reasonably likely to become insolvent which the immediately ensuing six months.
- There appears, in my opinion, to at least be a reasonable prospect that creditors will directly benefit from the Company being afforded additional time to restructure its affairs, business, property, debt, other liabilities and equity in a manner that maximises the likelihood of the Company continuing in existence on a solvent basis.
- 9 Business rescue will allow the Company to realise its assets, procure additional funding or to achieve a compromise-or come to an arrangement acceptable to its creditors and other stakeholders.
- 10 The Business Rescue process will allow for:
- 10.1 The temporary supervision of the Company, and for the management of its affairs, business and property;
- 10.2 A temporary moratorium on the rights of claimants against the Company or in respect of property in its possession;
- 10.3 The development and implementation, if approved, of a plan to realize the Company's assets will result in a better return for the Company's creditors or shareholders than would result from the immediate liquidation of the Company.
