do hereby make outh and say that:

- I am an adult male chartered accountant practising from the eighth floor, Letterstedt House, Claremont, Western Cape. I am also a business rescue practitioner and a director of HS Advisory Services (Pty) Ltd.
- H5 Advisory Services (Pty) Ltd operates as a bookkeeping, accounting and tax compliance business.
- This business is distinct from the business Hobbs Sinclair Business Solutions (Pty) Ltd, a company which undertakes, inter alia, business record services.
- 4. On 11 April 2014; HS Advisory Services (Pty) Ltd, received a summons in respect of monies allegedly owing to a company Dotcom Trading 118 (Pty) Ltd in respect of services readered to a company Wilenri Appliance Services (Pty) Ltd, of which I was the business rescue practitioner duly appointed on 21 May 2012.
 - 5. The action was defended by HS Advisory Services (Pty) Ltd in the first instance, on the basis that there was never a contract between Dottom Trading 11S (Pty) Ltd and HS Advisory Services (Pty) Ltd, and in the second instance that these services were never rendered.
 - The grounds for these defences, based on the guidance of our legal team, appeared sound and based on this legal advice we engaged in action to defend the matter.
 - Prior to the matter going before the court an offer of settlement was made by HS Advisory Services (Pty) Ltd, which offer was not accepted by the Dotcom Trading 113 (Pty) Ltd.
 - In late November 2017, the first defence, that there was no contract between Dotcom Trading 118 (Pty) Ltd and HS Advisory Services (Pty) Ltd, was argued in the High Court in Case Town.
 - On or about 13 December 2017, the court ruled that a contract did exist between the parties.
 - Following this judgement, I approached Mr Mark Mans, the owner and director of Dotcom Trading 118 (Pty) Ltd, and once again proposed a settlement. This settlement offer was rejected.
 - Following the judgement, the company of December 2017, application was made for leave to appeal the decision of the high court. This application was subsequently denied.
 - The situation has now arisen, whereby costs with regards to the above court actions, which
 are currently being taxed, have been awarded against HS Advisory Services (Pty) Ltd.
 - 13. Our repeated efforts to settle this matter have been unsuccessful.
 - 14. Although the company does trade profitably on a day to day basis, the untaxed bill in the amount R 911 733 places the company in situation where it is financially distressed, commercially insolvent and it does not have the resources to continue defending this matter.

Under these circumstances, I believe the company should be placed into the hands of an independent Business Rescue Practioner who will take charge of the company and develop a Business Rescue Plan to protect the interests of all affected parties, including the 27 employees who earn their Evelihood from the company.
- 16. The company has traded successfully since its inception in 1999. The legal action against the company and the ruling of the High Court has been unexpected and cut of the ordinary as it does not relate to the day to day activities of the company.
- For this reason I believe that there is a reasonable expectation that the company can be
 rescued and the directors have resolved to place the company into business rescue with
 immediate effect.
