- 1 I am a South African and the appointed member Mike's Mechanical and Tractors CC ("the EC") with registration number 1996/056832/23 and business address at 106 Park Drive, St Georges, Port Elizabeth, 6001
- The contents of this sworn statement are true and correct and, unless stated otherwise, the facts contained herein fall within my own personal knowledge and belief.
- 3 I was duly appointed as member of the CC on 7 March 2013.
- 4 I make this swom statement in support of the CC's notice to commence business rescue proceedings as contemplated in terms of Section 129 of the Companies Act, 71 of 2008 ("the Act").
- On 16 April 2019, the members of the CC unanimously resolved that the CC voluntarily commence business rescue proceedings as envisaged in terms of the Act. The resolution will be filed together with this sworn statement.
- 6 The relevant facts upon which the resolution were founded include:
- 6.1 The CC's main business is that of an agent for the sale of tractors and tractor parts.
- 6.2 According to the CC's records it is indebted to its creditors in an amount of some R5000 000 (five million rand).
- 6.3 The CC requires time in order to restructure its affairs, debt and equity so that the creditors of the CC are afforded maximum benefit,
- 6.4 As mentioned in 7 below the CC is financially distressed as envisaged in terms of the Act.
- 6.5 Funding from sources such as members' loans and the CC's financiers.
- The CC is faced with the situation where it needs to realise its assets or to procure further funding to best effect and to negotiate with its creditors which process will be best achieved under business rescue proceedings as envisaged in terms of the Act.

- As member I investigated the CC's affairs and concluded that the CC is "financially distressed" as defined in section 128 of the Act as it is reasonably unlikely to be able to pay all its debts as they become due and payable within the immediately ensuing six months and/or the CC is reasonably likely to become insolvent within the immediately ensuing six months.
- There appears, in my opinion, to at least be a reasonable prospect that creditors will directly benefit from the CC being afforded additional time to restructure its affairs, business, property, debt. other liabilities and equity in a manner that maximises the likelihood of the CC continuing in existence on a solvent basis.
- 9 Business rescue will allow the CC to realise its assets, procure additional funding or to achieve a compromise or come to an arrangement acceptable to its creditors and other stakeholders.
- 10 The Business Rescue process will allow for:
- 10.1 The temporary supervision of the CC, and for the management of its affairs, business and property;
- 10.2 A temporary moratorium on the rights of claimants against the CC or in respect of property in its possession;
- 10.3 The development and implementation, if approved, of a plan to realise the Company's assets will result in a better return for the CC's creditors or shareholders than would result from the immediate liquidation of the CC.
