- 1. I am an adult male and Director of Southern African Tyre Distributers (Pty) Ltd, Registration Number: 2014/174250/07(hereinafter referred to as the "Company").
- 2. The contents herein contained are true and correct and within my own personal knowledge, unless it appears to the contrary from the context.
- 3. I am duly authorized to depose to this affidavit on behalf of the Company.
- 4. I confirm that it was resolved on the 25th of September 2019 by the Directors of the Company that the Company was financially distressed and that there appeared to be a reasonable prospect of rescuing the Company. Accordingly, it was resolved that the Company would voluntary begin business rescue proceedings.
- 5. Below are the events that lead to the above decision:
 - Prior to the actions of the company's major funders being DG Capital (Pty) Ltd ("DG Capital") and Grindrod Bank Ltd ("Grindrod") described in point 2 below, the company had engaged with various funders to recapitalize the company. These actions are ongoing.
 - We were advised on Thursday 5 September that DG Capital intended to perfect their notarial bond security supporting their stock financing facility and had advised Grindrod accordingly.

- 3. On Thursday 12 September 2019 we were advised by DG Capital and Grindrod that they had perfected their securities in the High Court.
- 4. In the week beginning 2 September 2019, it became apparent that Grindrod would not approve further drawdowns on the company's Debtor Financing Facility.
- 5. We (my fellow directors and I) met with DG Capital and Grindrod on a number of occasions to consider various refinancing and immediate funding proposals although these came to naught as it appeared that DG Capital would only consider proposals that contained shareholder guarantees which we were not confident we could raise in the time given.
- 6. Therefore, based on the above I am if the opinion that the Company must be placed under business rescue and it is the Company's recommendation that BDO Business Restructuring (Pty) Ltd be appointed as the Business Rescue Practitioners in this matter.
- 7. I confirm that this individual does not have any other relationship with the Company, such as would lead to a reasonable and informed third party to conclude that the integrity, impartiality or objectivity of these persons are compromised by the relationship.

8. Furthermore, as far as the Company is aware and to the best of my knowledge, the proposed practitioners are of good standing in their respective fields and that they are not related to a person who has a relationship with any person who has been disqualified from acting as a director of the Company.
